



Reservation and general conditions Country Camp (fully-equipped tents)

Prices

Rents for the tent include rental of the pitch and use of electricity, gas and water. On many sites you pay separately for the use of shower and hot water. Furthermore, you pay tax at the camp site owner and any environmental taxes.

Preferred booking

If you prefer your reservation (eg for a particular place on the site) have shown, you pay € 15, - extra. We do our utmost to realize your preference, but can not guarantee it.

Cleaning

For the final cleaning we always € 25, - fee. You are responsible for leaving for doing the dishes, emptying the trash and wipe clean leaving the tent.

Deposit

You pay on arrival at the campsite a deposit of € 75, -. Upon departure you will receive the deposit back. Any damage, loss and / or (extra) cleaning will be deducted from the deposit.

Payment

Within two weeks of receiving the reservation confirmation → do a down payment of 40% of the total amount (at least € 150, -) plus the premium of the insurance and the reservation fee. The remainder will then be due eight weeks before your departure date. If you book within ten weeks before departure, you will pay the entire amount at once. In late payment Country Camp has the right to the reservation - after the summons - to cancel, then you are personally responsible for the cancellation. Negligent in paying all costs for your account.

Change

For changes after booking we € 20,- administration costs. Changes which include a partial cancellation, are part of the cancellation of the → where applicable. When you are staying at the campsite the reserved period will renew at the extra time directly on the site. This is subject to the prices in our brochure are, in this situation you can not use an offer.



Modification / cancellation by Country Camp

Country Camp as the reserved accommodation may not offer the tenant receives this message immediately. You get a similar alternative without increasing the fare. If you make no use, you will receive within two weeks fare and reservation costs. Country Camp is not held in cases of force majeure, such as the imposition of emergency rule in the area of the campsite, the outbreak of infectious diseases to humans and / or animal can be dangerous and threatening floods.

Cancellation

Reservations can be canceled only in writing. The cancellation fees are: 25% of the rental price for cancellation up to eight weeks before the booked period (minimum € 115, -) and 50% of the rental sum → cancellation between eight and four weeks before the booked period (minimum € 115, -). Cancellation within four weeks before the booked period, the full rent. If you arrive later or earlier departure than the tent aside, there is no refund.

Liability

Country Camp is not liable for damages and / or injury while staying at one of our sites, regardless of cause. This also applies to loss, theft or damage to personal property or money.

Complaints

The brochure and the website of Country Camp with the greatest care co → → → you set, for obvious errors and modified independently to → → Country Camp today can not accept liability. Despite our best efforts it is possible that the tenant has a legitimate complaint about the accommodation or facilities.
